The Rideau Hall Foundation (RHF) aims to support dramatic increases in the numbers of First Nations, Inuit, and Métis (FNIM) teachers in Canada by 10,000, focusing on K-12 educators. For this funding stream, the focus is on supporting Indigenous Teacher Education Programs (ITEPs) that are in-development or scaling their program. The RHF will invest in innovative projects from coast to coast that reflect pathways for systemic change in Indigenous Teacher Education. Please explore the full grant guidelines before starting your application.

TYPES OF APPLICANTS

Past Grant Recipients

- If an organization/institute has been awarded funding by the Rideau Hall Foundation from the 2023 ITE Open Call, it is only eligible to apply for the Retain Stream of funding in 2024.
- If a past grant recipient partners with another organization, they are eligible to apply to the Reinforce Stream of funding so long as the lead applicant is not the grant recipient.

New Applicants

- New and returning ITE grant applicants are eligible to apply to both streams.
- New and returning ITE grant applicants may also apply for the same stream with multiple applications, as long as the proposed projects are distinct.
- Applying organizations/institutes cannot be awarded funding through both streams.

Partnerships/Collaborations

- Applicants are able to submit a joint application in partnership with other entities.
- For applications that include one or more partnerships, the application must identify the lead organization/institute as they will receive the funding and assume responsibility for any reporting and grant management with Rideau Hall Foundation.
